CONSENT JUDGMENT

1. Whereas, on September 12, 2016, the Board of School Directors of Pine-Richland School District passed a resolution ("Resolution 2") which reads in its entirety as follows:

This resolution agreed to by a majority of the Board of Directors of the Pine-Richland School District indicates our support to return to the long-standing practice of providing sex specific facility usage. All students will have the choice of using either the facilities that correspond to their biological sex or unisex facilities. This practice will remain in place until such time that a policy may be developed and approved;

- 3. Whereas, on February 27, 2017, this Court issued an Order Granting in Part Plaintiffs' Motion for Preliminary Injunction and Denying Without Prejudice the Defendants' Motion to Dismiss (ECF #77);
- 4. *Whereas*, the parties to this litigation desire to settle the issues raised by Plaintiffs' Complaint and subsequent proceedings without the necessity of further litigation;

5. Whereas, the parties have reached a settlement agreement and consent to entry of

the following final and binding consent judgment as dispositive of all issues raised in the above-

captioned matter; and

6.

Whereas, the parties intend this Consent Judgment to benefit all students, including

transgender students, within the Pine-Richland School District and to be binding on the District

unless and until modified by the Court on motion with proper cause shown under Federal Rule of

Civil Procedure 60.

Accordingly, it is hereby ordered, adjudged, and decreed:

1. Defendants, their officers, employees, and agents; all persons acting in active

concert or participation with any Defendant, or under any Defendant's supervision, direction, or

control; and all other persons within the scope of Federal Rule of Civil Procedure 65, are enjoined

from enforcing Resolution 2 or any policy, practice, or custom of the Pine-Richland School District

and/or Pine-Richland High School that denies transgender students the access and use of restrooms

that match a student's consistently and uniformly asserted gender identity; and taking any formal

or informal disciplinary action against transgender students for using the restrooms that match a

student's consistently and uniformly asserted gender identity.

2. This Consent Judgment shall remain binding on the District unless and until

modified by the Court on motion with proper cause shown under Federal Rule of Civil Procedure

60.
