#### REDACTED AFFIDAVIT OF JOSHUA D. ZOLLICOFFER a/k/a PASSION STAR

I, Joshua D. Zollicoffer a/k/a Passion Star, having been duly sworn, upon my oath state as follows:

- 1. I am the plaintiff in this lawsuit. I am a 31-year-old adult, and I am competent to testify as a witness in this case. Except where otherwise noted, the facts set forth herein are of my own personal knowledge, and if called upon as a witness, I could and would testify competently to such facts. I have reviewed my complaints, grievances, appeals, and related documents and am familiar with their contents.
- 2. I am a transgender woman, meaning that I was assigned the sex of male at birth, but I identify as a woman. Since I was a teenager, I have known that I was attracted to men.
- 3. I have been in the custody of the Texas Department of Criminal Justice ("TDCJ") since 2003. I have been housed in sex-segregated male facilities.

- From 2003 to 2006, I was housed in the Telford Unit in New Boston, Texas 4. ("Telford"). From 2006 to 2007, I was housed in the Allred Unit in Iowa Park, Texas ("Allred"). From 2007 to 2008, I was housed in the Smith Unit in Lamesa, Texas ("Smith"). From 2008 to 2011, I was housed in the Coffield Unit in Tennessee Colony, Texas ("Coffield"). From 2011 to 2013, I was housed in the Hughes Unit in Gatesville, Texas ("Hughes"). From December 2013 to November 2014, I was housed in the Robertson Unit in Abilene, Texas ("Robertson"). In November 2014, I was transferred to the Clements Unit in Amarillo, Texas ("Clements"). From November 2014 to the present, I have been housed in Clements.
- In each of these seven facilities, male inmates have directed unwanted sexual 5. advances at me. Male immates have demanded that I perform sexual acts for them or pay them for protection and have threatened to assault me if I did not submit and perform sexual acts for them.
- In all of these facilities, a large number of the male inmates have perceived that I 6. am not a heterosexual man. While some inmates confuse being transgender with being gay, the fact that I am not a heterosexual male was generally known in the units where I lived. I believe that most of the male inmates in the units where I was housed thought I was a transgender woman or a gay man because of my feminine mannerisms, my soft voice, and the way that I walk and talk. I have heard inmates tell one another than I am a "punk," a term used to refer to feminine people in custody. As a result of my female gender identity and my perceived sexual orientation, male inmates in all the facilities where I have been housed have sexually harassed, threatened, and/or assaulted me.
- There is a custom in TDCJ pursuant to which gay men and transgender women are targeted by other inmates, frequently inmates with power and influence in the unit, often gang

members, and forced to perform sexual acts as a means of survival because otherwise they will be assaulted. Sometimes we are made to perform sexual acts for many members of the same gang. This is called "riding." Because gay men and transgender women are not protected by TDCJ staff, we are often cocreed unwillingly into unwanted sexual encounters to escape physical assault if we try to resist.

- 8. Since 2003, I have complained numerous times to TDCJ officials about the sexual abuse, the threats, and the violent attacks against me. I have informed TDCJ staff that I am transgender or homosexual (because I thought they would understand the term "homosexual"). I have exhausted dozens of grievances related to threats against me and asked dozens of times to be housed in safekeeping, but each time my requests for safekeeping have been denied. I have been left in the general population of the TDCJ facilities to fend for myself.
- 9. As a result of begging TDCI staff to help protect me, I have found myself in more danger. Each time that I ask for help and am returned to the general population, other incarcerated people suspect that I am a "snitch." I have learned from my time in prison that the prison culture is one of retribution and violence against people who snitch. As a result of asking for help from TDCJ staff who have refused to take reasonable steps to protect me, I have been placed at greater risk of serious harm.
- In Telford, I was identified as feminine and forced into a relationship with 10. ("M.M."), who was a high-ranking member of a gang. I was nineteen. I thought that he could protect me from the other inmates in Telford who were sexually harassing me, but he forced me to perform sexual acts for him. When I tried to end the relationship, M.M. choked me, so I stayed in the "relationship" with him.

- After the rape, I was transferred to Smith. Because the rape was documented, I 12. thought that it would be obvious to TDCJ employees that I needed more protection than was available in the general population. I begged to be put in safekeeping, but I was placed back in the general population without protection where I was sexually harassed and threatened with rape again by several different men incarcerated in Smith. One cellmate, REDACTED ("O.R."), threatened to assault me and forced me to watch him masturbate.
- 13. When I arrived in Coffield in 2008, I again faced threats of sexual violence from men incarcerated with me, including ("K.H."), who is currently incarcerated with me in Clements. Soon after arriving, I was forced into a sexual "relationship" with REDACTED ("T.K."), a powerful inmate on the unit, because he threatened to assault me if I did not submit. and because the guards would not protect me. When I tried to end the relationship, T.K. punched me on the left side of my jaw, breaking one of my teeth and causing it to puncture my lip.

#### Transfer to Hughes

14. When I was transferred to Hughes in 2011, I experienced the same attempts to force me to perform sexual acts against my will and threats of sexual and physical violence. I submitted and appealed numerous grievances related to the threats to my safety, but I was forced to remain in the general population among the inmates who were threatening and assaulting me.

- As an example of some of the threats, on December 25, 2011, inmate affiliated with the Crips gang, who regularly called me a "faggot," attacked me, punching "H.X.") and other Bloods my head, face, and torso. In or around March 2012, gang members demanded that I pay them for their protection or "ride," meaning perform sexual ("R.B.") threatened me with acts for their gang. In 2013, an immate named violence if I did not submit to his demands for sexual acts. In 2013, a Bloods gang member "A.X.") sent me sexually explicit letters, demanding that I perform sexual acts known as 'C.Y.X."), made for him in return for his protection, and another Blood, known as similar demands.
- I informed officers and submitted numerous grievances related to the threats to 16. assault me and demands that I perform sexual acts, but TDCJ staff did not move me to the dorms, place me in safekeeping, or take others steps to protect me. Instead, Lieutenant Aragon called me a "snitch" and "punk" in front of other inmates during lineup. Officer Thompson and other officers routinely pretended to grab my buttocks, which they referred to as the "grab-ass game."
- On May 12, 2013, C.Y.X. and A.X. jointly confronted me while I was at church 17. and accused me of "snitching" on them. C.Y.X. said that a correctional officer had informed him that I had reported that he was a gang member. A.X. punched me on the right side of my jaw, causing swelling and pain to my jaw and face. I went to the infirmary.
- ("F.X.") threatened to assault me if I did not In October 2013, 18. perform sexual acts with him. When I refused, he attacked me on or around October 2, 2013 in

the hallway by the dining hall, cut my lip and my left hand, caused swelling and bruising on the left side of my face and jaw line, and left a knot on the left side of my head.

- 19. In 2013, ("J.T."), a member of the Crips gang, sexually propositioned and threatened me whenever he saw me. The situation with J.T. soon escalated.
- 20. On November 4, 2013, I met with the Unit Classification Committee ("UCC") headed by Defendant Ralph Marcz, Jr.. I told Defendant Marez and the other members of the UCC that I was gay with a female alias, that I had been raped in the past, and that I had been repeatedly threatened with sexual and other violence. I explained that I feared for my life and requested to be reassigned to safekeeping and protected. The UCC denied my request for additional protection.
- 21. I submitted grievance step 1 #2014040489 on or around November 6, 2013, appealing the UCC's decision. When Defendant Blanchard denied my grievance, I appealed this grievance, step 2, on or around November 15, 2013. In the grievance, I wrote that I live with the "constant threat of being hurt" because I am gay and effeminate in the general population and that I have been assaulted and threatened in the past. I also wrote that transferring me from one pod to another pod or one unit to another unit was not sufficient to prevent assaults against me. A true and correct copy of grievance #2014040489 is attached hereto as Exhibit B.
- 22. On November 13, 2013, during a church service, J.T. threatened me again. He said loudly in front of other Crips that I "belonged" to him. He told me that refusal was not an option and that since I was gay, I had to "stay in a ho's place." The other Crips threatened to assault me if I did not submit to J.T.
- 23. I complained to TDCJ staff about the threats and asked for protection, but the staff did not take action to help me. Officer Johnson told me, "You've fought once. Fight again."

- 24. On November 19, 2013, I again appeared in front of the UCC, composed of Defendant Blanchard, Defendant Leslie Walters, and Defendant James Sigmund. I told them about the threats I received from J.T. and other inmates, the rape in 2007, and the recent assault by F.X., and I again requested to be placed in safekeeping. Defendant Blanchard, Defendant Walters, and Defendant Sigmund denied my request for protection and ordered me to be returned to "the next available cell" in my custody level in the general population.
- 25. On November 19, 2013, I was moved into 8 Building, L-Pod 52 Cell. This was the same pod where J.T. was housed.
- 26. I knew that I was going to be assaulted or possibly killed even though I had done everything in my power to be protected. I immediately filed an emergency grievance appealing the UCC's decision to deny me safekeeping and move me closer to J.T. I requested again to be moved to safekeeping and explained that I was gay and that J.T. and other Crips had threatened to assault me if I did not "ride." A true and correct copy of grievance #2014048625 is attached hereto as Exhibit C.
- 27. On this same day, on my way to the dining hall, I also appealed to Defendant Prince Pickett, the 8 Building supervisor, for help. I explained my history of threats and violence by other inmates against me, and told him that I had already received threats from Crips gang members since being moved to L Pod. Defendant Pickett told me that it was "not [his] problem" and did not do anything to help me.
- 28. The very next morning, November 20, 2013, the assault that I had been begging to be protected from occurred (the "Razor Attack"). J.T. and other Crips gang members brutally attacked me from behind as I headed to breakfast. J.T. called me a "snitching faggot." As others watched, J.T. repeatedly slashed my face with a razor while I struggled. I thought he was going

to kill me. One cut came within a quarter of an inch of my right eye. I bled profusely and suffered intense pain. As a result of this brutal attack, I was taken to Correctional Managed Care. A true and correct copy of my medical records from November 20, 2013 is attached hereto as Exhibit D.

- On November 20, 2103, after the Razor Attack, I submitted another step 1 29. grievance, asking to be placed in safekeeping. A true and correct copy of grievance #2014049246 is attached hereto as Exhibit E.
- On November 22, 2013, two days after the Razor Attack occurred, Defendant 30. Rene Maldonado denied my emergency step 1 grievance #2014048625 in which I requested assignment to safekeeping that I had submitted on November 19, 2013, prior to the Razor Attack. Defendannt Maldonadowrote that the "committee did not find sufficient evidence to support your allegations" even though by that time I had physical injuries from the brutal attack by J.T. and had been treated by Correctional Managed Care (See Ex. C).
- On November 22, 2013, the UCC, composed of Defendant Blanchard, Defendant 3I. Walters, and Defendant Sigmund, again denied my request for safekeeping and instead recommended that I be transferred to the general population of another unit. I believe that they knew that recommending unit transfer was not sufficient to protect me and knew that I would still be vulnerable to sexual assault and retaliation, that gangs operated throughout TDCJ, and that I would be targeted by members of J.T.'s gang in the new unit. While informing me on November 22, 2013 of the UCC's decision to transfer me rather than place me in safekeeping, Defendant Blanchard told me, "Now I bet you really feel like your life is in danger." When he said this, I felt like I wanted to cry.

On November 29, 2013, I wrote step 2 to grievance #2014049246, appealing the 32. decision to send me to the general population in a new unit. I wrote:

simply recommending that I be transferred off the unit isn't enough to ensure that I am no longer victimized. . . . I followed instruction and was placed back into a position to be hurt -knowingly. So, I request safekeeping away from the general population of offenders that have victimized me and will continue to do so.

(Ex. E). On January 8, 2014, Defendant Armstrong denied my appeal, indicating that I had been designated "not for same unit" as J.T., transferred to Robertson, and that no further action was warranted. (Id.).

#### Transfer to Robertson

- 33. On December 6, 2013, TDCJ officials transferred me to the general population in Robertson.
- 34. Soon after, I learned from other inmates that J.T. had been housed in the general population of Robertson prior to his transfer to Hughes and was well known among inmates at Robertson as a high-ranking member of the Crips. Soon after I arrived, I learned that ("T.T."), a Crip, spread the word among the Crips in Robertson that I was a "snitching faggot" and told me that the Crips in Robertson would finish what J.T. started. Other immates in Robertson asked me about the lacerations on my face and figured out that J.T. was the one who had done it. From my prior assaults and grievances, TDCJ staff knew that I was the enemy of a well-known Crips gang member (J.T.), but TDCJ staff took no measures to protect me in this new unit.
- 35. I requested an Offender Protection Investigation on ("OPI") or around December 11, 2013. Sergeant Juan Lopez ("Lopez") reviewed the paperwork in front of me. He told me to "suck dick, fight or quit doing gay shit but quit running me with OPIs." He was very clear that he cared more about not having extra paperwork than protecting my life.

- On December 12, 2013, I appeared before the UCC in Robertson headed by 36. Assistant Warden Adam Gonzales ("Gonzales"). I told Assistant Warden Gonzales and the other members of the UCC that I was gay; had a history of coercion and sexual and physical assaults in other TDCJ facilities, including the recent Razor Attack by J.T.; and was afraid that I would be targeted by the Crips in Robertson once they learned about the incident with J.T. I explained that I feared for my life and requested to be placed in safekeeping.
- Assistant Warden Gonzales and the other members of the UCC denied my request 37. for safekeeping and placed me in the general population in Robertson.
- On January 30, 2014 and February 6, 2014, Defendant Armstrong denied my step 38. 2 appeal of grievances #2014040489 and #2014048625, in which I had requested to be placed in safekeeping, even though I told him that I was gay; that I had been sexually assaulted, raped, and threatened in the past; and that I was afraid that I would be assaulted again if I had to remain in general population. (See Exs. B & C).
- 39. Incarcerated people in Robertson also identified me as feminine because of my mannerisms and the way that I dressed and talked. Other inmates also frequently used female pronouns to refer to me, sometimes used derogatory terms like "punk" and "faggot," and propositioned me for sex. For example, a Crips gang member known as ("C.G.X.") repeatedly pressured me to perform sexual acts for him in return for my safety. C.G.X. told me that I had to find a man to protect me or be raped.
- In or around March 2014, I received a letter threatening to kill me from an inmate 40. ("P.N."), also a member of the Crips. known as
- 41. I felt desperate and fearful, so in or around March 2014, I sent letters to Defendant Joni White because she was the head of the State Classification Committee ("SCC"), and I hoped

- 42. I appeared in front of the UCC headed by Assistant Warden Gonzales on April 7, 2014, and again explained the threats to my safety, including the "kite" from P.N., the sexual threats from C.G.X., and the threats to my life from T.T. Assistant Warden Gonzales and the other members of the UCC denied my request to be placed in safekeeping. Instead, they recommended that I be transferred to the general population of yet another unit.
- 43. I appealed the denial of my request to be moved to safekeeping on April 9, 2014 in step 1 of grievance #2014125239. I wrote that the dangers to me were:

all rooted in the fact that I am a homosexual housed in the gang influenced general population of offenders. . Just recommending that I be transferred to another unit will not ensure my safety, just as it did not after the 3-29-07 sexual assault, nor after the 11-20-13 assault with a weapon. I am an offender with a 'potential for victimization', otherwise I wouldn't be constantly victimized and threatened by other offenders.

A true and correct copy of grievance #2014125239 is attached hereto as Exhibit G.

- 44. I also submitted requests in May 2014 to Officer Scott, the Safe Prisons Program's Coordinator at Robertson, formally requesting to be identified as transgender and informing him that I had received threats as a result of my identity in the past. A true and correct copy of requests submitted to the Safe Prisons' Coordinator is attached hereto as **Exhibit H**.
- 45. I also submitted and appealed grievance #2014140325, where I laid out the threats to my safety. I wrote that, "I've been traumatized by past experiences and fear repeating them.

This can only be rectified by housing me on safe keeping away from the general population of offenders looking to victimize me." A true and correct copy of grievance #2014140325 is attached hereto as Exhibit I.

- 46. On May 30, 2014, I learned that the SCC, headed by Defendant White, had not only rejected my request to be moved to safekeeping, but that the SCC had also rejected the UCC's recommendation that I be transferred to a different unit. This meant that the SCC thought I should be placed back in the general population in Robertson in the midst of the inmates whom members of the UCC had been informed were threatening me. I was terrified. (See Ex. G).
- 47. On this same day, May 30, 2014, I spoke to Ms. Trail, an officer attached to the Safe Prisons Program's Office in Robertson. I explained that I was gay and feared for my life. She recommended that I be placed in safekeeping.
- 48. On June 5, 2014, I appeared in front of the UCC headed by Assistant Warden Gonzales. He informed me that the UCC had adopted the Safe Prisons coordinator's recommendation that I be placed in safekeeping. Assistant Warden Gonzales told me that the UCC was forwarding the recommendation that I be placed in safekeeping to the SCC, headed by Defendant White, but added that, "They probably won't grant it."
- 49. On June 17, 2014, I learned that the SCC has denied the UCC's recommendation that I be placed in safekeeping. This was confirmed to me later in writing in grievance #2014205241 by Defendant Webb, who wrote: "You were reviewed by UCC on 6-5-14, and recommended for safekeeping status. On 6-16-14, this request was denied by SCC." A true and correct copy of grievance #2014205241 is attached hereto as Exhibit J.

- On this day, June 17, 2014, Senior Warden Fox moved me to a different building, 50. Building 3, in the general population at Robertson, where I feared that I would continue to be targeted by the Crips gang and other inmates.
- Soon after I was returned to the general population, I learned from another inmate 51. that T.T. had spread word to the Crips gang members in Building 3 that I was a "snitching ("T.K.X."), a Crips gang member in Building 3, told me that faggot" who should be killed. I would be killed. He called me a "snitch" and a "faggot" and said that I could not "run forever" but will sooner or later "have to face the consequences" because I rejected J.T. and tried to press charges against him. I received similar threats of assault and murder from other members of the Crips in Building 3.
- 52. I filed step 1 of grievance #2014187421 on July 21, 2014, detailing the threats I had received from Crips gang members in the new building. I said that the Crips wanted to retaliate against me because of my conflict with J.T. while at Robertson. I wrote, "I have been told that I will be killed if I remain in population." A true and correct copy of grievance #2014187421 is attached hereto as Exhibit K.
- On July or around 25, 2014, the day after I first met with an attorney to discuss 53. what had happened, Sergeant Marquez moved me into "lock-up," a cell in solitary confinement, which is used to discipline inmates. I remained in solitary until August 8, 2014, when I was transferred to "transient" status to await a decision from the SCC. The transient cell is essentially the same as the solitary confinement cell, and the restrictions are nearly the same. The only real difference is that in transient status, I have electricity. Being confined in isolation is its own form of torture because I have little human contact; I cannot sleep; I continuously think about past traumatic experiences; and I suffer psychological distress. I have felt deterred from filing

complaints about threats of sexual abuse because I do not want to be placed in isolation again. While in transient status, I was also afraid that at any moment I could be released back into the general population and killed.

- 56R1264~T When I asked Defendant Lopez why I was stuck in solitary without a hearing or a 54. disciplinary infraction, Officer Lopez told me to "quit filing OPIs" if I did not want to be in solitary.
- On August 1, 2014, I appeared in front of the UCC headed by Assistant Warden 55. Webb. I again explained my problems and the death threats that I had received from inmates at Robertson. I told the UCC members that my problems related to me being a transgender woman confined in the general population in a male prison. Defendant Webb replied, "It's a man's prison. You can't expect to walk around acting like that and not have problems."
- 56. Assistant Warden Webb denied my request for safekeeping and recommended that I be transferred to the general population in a different unit, even though I believe be understood that as a transgender woman, I would have the same problems in general population of a new unit.
- 57. On or around August 4, 2014, I submitted grievance #2014192951, and on August 11, 2014, I submitted grievance #2014196990, outlining the threats made to my safety by gang members and requesting placement in safekeeping. In the August 11, 2014 grievance, I wrote:

[T]ransferring me from unit to unit in general population does nothing to rectify this problem that is pervasive. . . . I have been threatened with my life as well as threatened with rape. Housing me in general population to repeat the same cycles with different offenders is absurd. . . .

A true and correct copy of grievance #2014196990 is attached hereto as Exhibit L.

58. The next day, on August 12, 2014, I again wrote directly to SCC, headed by Defendant White, requesting placement in safekeeping. I identified myself as a transgender woman and again explained that my "life is in danger." A true and correct copy of my August 12, 2014 letter to the SCC is attached hereto as Exhibit M.

- I was terrified waiting to learn what the SCC would decide. After so much time in 59. solitary and transient status, I was feeling depressed, upset, alone, isolated, and hopeless. I was having trouble sleeping. The transient status cells (which are materially the same as administrative segregation and solitary confinement cells used to punish inmates) are very small, approximately 10 feet by 8 feet, and I was confined to this cell for 23 hours each day. While housed in transient status or solitary, there were restrictions on my calls with family, visits from my family, working, going to church, and going to the law library or the regular library. My mother and sister had to cancel a trip to visit me planned for or around October 17, 2014 because I was in transient status. Because I was in transient status, I was also prevented from participating in the Cognitive Intervention Program and the College Trades Program, both programs that I would like to join.
- 60. While waiting in isolation to find out whether I would be sent back to the general population in Robertson or sent to the general population of a new unit, I constantly thought about being raped, coerced and assaulted, and the fact that it could occur again in the future. I had nothing else to do but think about these things. I have known inmates who have gone "crazy" or committed suicide after being locked in isolation, and I do not want this to happen to me.
- 61. On October 6, 2014, I learned that on or around September 17, 2014, the SCC had rejected the UCC's recommendation that I be transferred to a new unit. This means that even though they knew all of my history and all of the current threats against me, the SCC thought it

was best to send me back into the general population of Robertson, where it was all but certain that I would have been seriously hurt, if not killed.

- On September 26, 2014, Defendant Fernando Fuster denied my step 2 grievance 62. #2014187421. (See Ex. K).
- On or around October 7, 2014, I learned that the UCC has appealed the SCC's 63. decision to send me back into the general population in Robertson.

#### Transfer to Clements

64. ON NOVEMBER 17, 2014 I WASTRANSFERRED PROM ROBERTSON TO CLEMENTS.

65. ON OR AROUND NOVEMBER 18,2014, I MET WITH THE UCC AT CLEMENTS. I REQUESTED TO BE PLACED IN SAFELEEPING AND EXPLAINED TO THE UCC THAT I AM A TRANSCHENDER WOMAN AND HAVE A HISTORY OF BEING TARESETED FOR SENJALABUSE AND ASSAULT WHILE IN THE GENERAL POPULATION. ONE OF THE MEMBERS OF THE UCC, CAPAIN DEAN, RECOGNIRED ME FROM COFFIELD, WHERE HE HAD PREVIOUSLY WORKED, AND TOUD THE OTHER OFFICERS ABOUT MY FEMALE CHENDER IDENTITY AND MY COERCED RELATIONSLIP IN COFFIELD, INSTEAD OF PROTECTING ME) THE MEMBERS OF THE UCC ASSIGNED ME HOUSENGE IN THE CHENERAL POPULATION AND MADE FUNDEMY IDENTITY.

66. FROM THE BEGINNING IT WAS CLEAR THAT THE SAFE PRISONS PROGRAMS OFFICE WOULD DO NOTHING TO PROTECT ME AND THAT THEY WOULD RETALIATE AGAINST ME IF I TRIED TO COMPLAIN ON OR AROUND NOVEMBER 18, 2014, I MET WITH THE SAFE PRISONS PROGRAMS COORDINATOR AT CLEMENTS, SERGEANT MAES, AND HER ASSISTANTS OFFICER GARCIA. I ALSO TOLD THEM THAT I AM TRANSMENDER AND HAVE A HISTORY OF BEWY ASSAULTED. DEFILER GARCIA TOLD METHAT THEY WOULD NOT TOLERATE MY FILMEN OPIS IN CLEMENTS LIKE I HAD DONE WOTHER UNITS. HE THREATENED TO CAUSE ME PRUBLEMS FOR ME INCLUDING WRITING ME UP AND PROVORING FLEILITS BETWEEN ME AND MY CEHMATE, IF I CONTINUED TO FILE REDUCESTS FOR PROTECTION AND GRIEVANCES. AS A RESULT, I FEEL THAT I CANNOT GO TO SAFE PRISONS PROGRAM WITH ANY CONCERNS FOR MY SAFETY AND THAT I

WILL FACE ADDITIONAL PROBLEMS IF I TRY TO SEEK PROTECTION.

67. SOON AFTER APPINION AT CLEMENTS, I BERDANTO HAVE PROBLEMS WITH MEN INCARCEPUTED ON THE UNIT WHO SAW ME, RECOENTED ME AS FEMININE AND TARGETED ME FOR SEXVALABUSE. OTHER INMATES REFERRED TO ME WITH FEMALE PROMOUNS AND SOMETIMES USED DEROCATORY TERMS LIKE "PUNK" AND "FACTORY" TO REFER TO ME.

ALMOST IMMEDIATELY. ("T.C."), A MEMBER OF THE MANDWED WARRIORS CHAVE WHO WAS HOUSED WITH ME IN 7 BUILDING, H-POD, BECAN TO PROPOSITION ME ACCOUNTED FOR," AND TOLD ME. "411 OF THE CIRLS ON THIS UNIT ARE ACCOUNTED FOR," AND "YOU HAVE TO HAVE A MAN."

IN FEBRUARY 2015, T.C. CONFRONTED ME IN THE DINING HALL AND DEMANDED THAT I "GIVE HIM SOME PUSY." I WAKED AWAY WHEN HE SAID THIS THREAT AND ASSAULT ME. WE ARE HOUSED ON THE SAME POD, AND HE HAS EAST ACCESS TO ME.

ABBRESSIVELY SEXUALLY PROPOSITION ME WHEN HE SAW ME INTHE DINING HALL I TRIED TO AVOID HIM, BUT THE STUATION ESCALATED WHEN HE ERABBED MY BUTTOCKS AND DEMANDED THAT I PERFORM SEXUAL ACTS FOR HIM. I WANTED TO REPORT THE INCIDENT TO THE SAFE PRISONS OFFICE BUT WAS CONCERNED THAT THIS WOULD BE COUNTER PRODUCTIVE.

69. IN CLEMENTS, I ALSO RECOGNITED SEVERAL PEOPLE WHO WERE PREVIOUSLY INCARCERATED WITH ME EITHER AT COFFIELD OR HUMINGS AND AM CONJCERNED THAT THEY WILL RESURRECT PROBLEMS THAT I HAD ON OTHER UNITS. 



DURING MY INCARCERATION I HAVE CONSTANTLY BEEN PREYED ON BY OTHER OFFENDERS AND HAVE COME TO SERIOUS HARM BECAUSE NO UNITS ADMINIST-RATION HAS TAKEN THE STEPS TO PROTECT ME. ON 3-29-07 I WAS SEXUALLY ASSAULTED ON THE Allred Unit. I WAS DENIED HOUSING ON SAFE REEPING AND SIMPLY TRANSFERRED TO ANOTHER UNITS GENERAL POPULATION TO FACE THREATS AND ABUSE.
